Plains Land Bank staff members, directors and guests celebrated the groundbreaking for a new Plainview office on June 1. The event was sponsored by the Plainview Chamber of Commerce and opened with a welcome address by Chamber Executive Director Linda Morris.

Kenneth Hooper, branch president for Plainview, described how the new facility — located at 3102 W. Seventh St., on the corner of West Seventh and Ennis streets in the College Hill subdivision — is part of Plains Land Bank's vision for growth in the coming years. "Plains Land Bank has made a significant investment in personnel and facilities across our territory," Hooper explained. "This office is a tangible reflection of our plan to grow not only loan volume, but service for our customers. The new facility provides three critical components: space for employees, improved customer access and improved visibility in the community."

Board Chairman Don James expressed appreciation to those in attendance, and echoed Hooper's sentiments regarding service to area producers. He recalled years past when he had visited the Land Bank office as a young man, expressing pride in the association and its financial services. CEO Gregg Lloyd further elaborated on the decision to move the Plainview office.

"The office at Seventh and Baltimore has been a Land Bank since the 1950s," Lloyd explained. "With remodeling and updates, it has served us well, but now it's time to move on. We are proud of this new facility and know it will have a positive impact in Plainview."

The new office is scheduled to open in early 2018.

FARM CREDIT WEEK

Plains Land Bank staff members, directors and customers traveled to Washington, D.C., in late July for Farm Credit Week, a gathering of more than 600 Farm Credit representatives from around the country. The three-day event included the launch of a new national campaign — One Mission. Many Voices. — as well as meetings with elected officials about the importance of passing a strong farm bill when the current legislation expires in September 2018.

The event began with a speech by U.S. Secretary of Agriculture Sonny Perdue, who said, "We need to be smart, be wise and be compassionate as we serve the farmers and ranchers of America."

Plains Land Bank representatives then met with Rep. Mike Conaway of Texas, chairman of the House Agriculture Committee, as well as Rep. Jodey Arrington, Sen. John Cornyn, Sen. Ted Cruz and Rep. Mac Thornberry.

Board Chairman Don James, CEO Gregg Lloyd and Vice President Jeff Taylor were joined on Capitol Hill by Plains Land Bank customers Dane and Lori Mullins, who were in Washington as participants in the Farm Credit Young Leaders Program. The Mullinses have a crop and cattle operation in Silverton, where Dane also is part owner of the Silvercot Inc. cotton gin and serves on the Silverton school board. The couple met at Texas Tech University and has three sons — Cooper, Jake and Knox. Customers since 2011, they work with Taylor, their loan officer in the Plainview branch.

The week ended with about 1,300 people gathering at the Library of Congress Great Hall for the Farm Credit Marketplace, where officials and Capitol Hill staff members sampled products made by Farm Credit customers across the nation.
