Built to Last...Is Your Farm?

As a farmer or rancher, one of the ways that success is measured is in how long the operation stays in the family. Our work is defined by how well the operation persists when things get tough. Seeking to have our names be synonymous with quality, we take pride in our operation. We like to build the farm with future generations in mind, but are we taking all the steps necessary to make that happen? Are our farms organized, and positioned strong enough to advance for multiple generations? For a farm to endure a generational transition there need to be short-term strategies for planting, harvesting, grazing rotations, etc. that not only get the job done, but also do so efficiently and profitably. There also need to be long-term plans in place that allow you to make strategic purchases of equipment or to have the cash flow necessary to bring the next generation back. Too often we get so focused on the short-term goals that we neglect what may be most important to the ultimate survival of the farm.

Every farm needs two types of plans, a contingency plan for ownership and a contingency plan for management. Below you will find a few questions that you should consider with both types of plans and then take action to assure success.

Contingency Plans for Ownership- This is a plan that lays out how ownership of assets (land, equipment, etc.) will flow if any of the current owners were to pass away. If you aren't clear on this, take some time to work through the exercise. You might be surprised and uncomfortable when you realize that your plan calls for you to be in business with your brother's wife.

Who would own the farm if any of the current owners passed away?

Do you have the cash to buy-out your partner's spouse if they died tomorrow?

What kind of relationship does your next generation

have with your Ag New Mexico Farm Credit lender? Contingency Plans for Management- This is a plan that lays out who currently makes management decisions, what decisions only one person makes and looks at the risk the farm faces if the operation lost certain managers. What decisions are made by only one person and how much risk does the farm have if such persons were not there to make those decisions?


How likely is it that the operation could keep doing business efficiently if any top leader was no longer in the company?

How can we prepare a next generation of capable and talented leaders?

The legacy of your work and your farm depends on you and the decisions that you make. What are the decisions that you should be making to assure that your farm or ranch will be around another generation?

Final Question: What is the potential impact of doing nothing?

No one is going to force you to put a plan together for ownership and management succession. Only you can decide that your farm and your family are important enough to get a plan in place. You can do it and Ag New Mexico Farm Credit wants to help make sure your farm and family legacy are celebrated for generations.
